Looking toward a brighter tomorrow

As we look to a new year, United Way of Frederick Countyis focused on new ways to deliver positive outcomes for local working families. There are more than 1 in 3 families who work every day, but struggle to afford safe housing, care for their children, and transportation.

Rising costs of everyday items on top of an already tight budget make it difficult for local struggling families to move forward.

United Way is moving the community forward with free budget coaching, credit counseling, tax preparation, rides to the grocery store, jobs, health care appointments, and matched savings to purchase a car or home. Your support helps ALICE families move forward on their Pathway to Financial Stability. Because of generous supporters like you:

- The Volunteer Income Tax Assistance (VITA) program provided free tax preparation and returned over \$980,000 to hard-working ALICE families.
- The Homebuyer Matched Savings Program had 26 new homeowners graduate in 5 years. 27 savers are close to purchasing their first home.
- The Used Car Matched Savings Program had 7 savers purchase safe, reliable vehicles in program's first two years.

"RUN" to Launch in Spring 2023


A transportation lifeline for local workers, seniors

In October, United Way hosted its annual Leadership Breakfast in person at the Evangelical Reformed United Church of Christ (ERUCC). We were thrilled to announce the anticipated launch of **Ride United Network (RUN)**, a partnership of ride providers who will collaborate to bring transportation solutions to ALICE families. RUN is set to launch in spring 2023.



The Breakfast featured County Executive Jan Gardner, who shared the importance of transportation for struggling households. It was also a pleasure to hear from Madelyn Hayward from TransIT, Leslie Schultz from Supporting Older Adults through Resources (SOAR), Suzi Borg from 211/Mental Health Association, and Melissa Muntz from SHIP of Frederick County. Each speaker shared personal stories about the critical need for transportation in Frederick County and how Ride United has become a lifeline for clients to get to work and school.

RUN will be a product of the Ride United pilot program, which provides ALICE households free or discounted rides to critical needs like employment and food. From 2021 to June 2022, Ride United provided over 4,200 rides to local struggling households.

20% of Veterans in Frederick County are ALICE

New ALICE in Focus: Veterans Report

They've served and sacrificed for our country, yet 20% of Frederick County's 15,750 veterans struggle to afford basic needs, according to a new report from United Way and its research partner United for ALICE.

New data shows that 20% of Frederick County residents who have served were designated as ALICE. They do not have income to meet the basic costs of housing, child care, health care, transportation and food.

While veterans show lower rates of financial hardship than individuals who never served, many of Frederick County's veterans, especially those in communities of color, face tough financial challenges.

35% of Frederick County's Black veterans and 30% of Hispanic veterans struggle to afford a basic cost of living. This is in comparison to 17% of White veterans. These ALICE levels are higher than the state of Maryland where 25%, 21% and 24% of Black, Hispanic and White veterans are ALICE, respectively.

Other findings show that veterans with disabilities struggled more to afford the basics — 21% — compared to 19% of veterans without disabilities. While working, veterans still experience financial hardship with 9% of veterans with full-time employment living in ALICE conditions. In addition, 47% of all Frederick County veterans are 65 years or older, 19% are ALICE and unable to afford basic needs.

United Way provides local veterans the resources they need to improve their lives. Contributions through our Moving Forward United campaign will help veterans with transportation to work, the grocery store, the library and doctor's appointments.

Asset Limited

Don't have a safety net for emergencies.

Income Constrained

Income falls short of covering basic necessities like food, housing, healthcare, child care and transportation.

Employed

Work but cannot afford a basic cost of living.
